GENERAL NOTICE

The Redstone Township Sewer Authority (Owner) is requesting Bids for the construction of the following Project:

REDSTONE TOWNSHIP SEWER AUTHORITY PHASE III SEWER PROJECT
CONTRACTS # 1, 2, 3, 4, 5, AND 6

Bids for the construction of the Project will be received at Redstone Township Sewer Authority, 1010 Main Street, Republic, PA 15475, until Thursday, November 14, 2024 at 1:00 PM Prevailing Time. Bids shall be sealed and clearly marked, "Bid for 21-048 Redstone Township Sewer Authority Phase III Sewer Project - Contract Number". At that time the Bids received will be publicly opened and read aloud on the same date as due at 1:05 PM Prevailing Time. Bids may not be withdrawn until: 90 days after due date.

THE PROJECT INCLUDES THE FOLLOWING WORK:

The project is located in the Villages of Orient, Filbert, Fairbank, Herbert, Tower Hill and Thompson in Redstone Township, Fayette County, PA and consists of the installation of approximately Sixty-Six Thousand, (66,000) Lineal Feet of 8-inch and 12-inch gravity sanitary sewer collection and conveyance facilities to include approximately Three Hundred and Fifty (350) sanitary manholes, Four (4) new wastewater pumping stations with approximately Fifteen Thousand (15,000) lineal feet of force main, an expansion/upgrade of the existing Redstone Township Sewer Authority Wastewater Treatment Plant (located along Dunlap Creek), and all associated restoration work on driveways, roadways and yards. The project will be separated into Six (6) separate contracts as listed in Section 01 12 50 - Summary of Multiple Contracts.
