**MONONGAHELA TOWNSHIP – SEAL COAT PROGRAM - 2025**

The scope of the work involves performing a seal coat per PennDOT Pub. 408 Specifications on four (4) Township Roads in Monongahela Township, Greene County. Estimated SY of seal coat on all roadways is 12,000 SY.

The bids will be publicly opened and read aloud at the Monongahela Township Municipal Building at 9:05 AM on Monday, April 28<sup>th</sup>, 2025.

Bids must be made on standard proposal forms, in the manner designated therein, and required by the specifications, must be enclosed in sealed envelopes, bearing the name and address of the bidder and the name of the project on the outside, addressed to Monongahela Township and must be accompanied by a Non-Collusion Affidavit and a bid bond or certified check for not less than ten percent (10%) of the base amount bid, and be delivered at the place on or before the hour named above.
